The 2022 Leadership Federal Executive Board (FEB) is a non-traditional leadership program, designed for executives, senior managers, and leaders within the federal sector by showcasing a myriad of federal agencies and leaders across Oklahoma. This program is specifically designed to assist participants:

- Balance management and leadership skills
- Expand leadership visions
- Enhance competencies, and
- Broaden perspective on other federal agencies

Leadership FEB consists of eight, one-day forums showcasing a variety of government agencies. Each forum will include but not limited to:

- Senior leader management briefings
- Interactive activities
- Tour of the agency or agencies
- Leadership book readings and discussions*

During each forum, participants will have the opportunity to actively engage in dialogue, exchange ideas, and explore unique challenges associated with leading federal agencies in Oklahoma.

*During the program, each participant will be required to assigned leadership books and/or videos as well as participate in follow on discussions. The leadership books and videos (traditional and/or audio) will be provided to each participant in advance, allowing sufficient time to read and become familiar with the new leadership concepts introduced.

- How other federal agencies and leaders manage priorities and resources
- New and advanced technologies
- Innovative techniques developed and efficiencies gained to response to challenges in the federal sector
- Leadership network: providing a forum from which to draw information and solutions

Leadership FEB Policies

Participants must attend at least five of the eight sessions to receive a Leadership FEB certificate of completion.

No alternates will be authorized to attend single sessions. However, if an identified participant becomes unable to honor their commitment to the program, the employing agency is authorized to replace that individual for the duration of the program.

Forums may involve agencies with missions requiring background investigations prior to the visit. If a registered employee has findings, their participation in that forum may be denied.
